Village Clean-up for St. Claire's Feast Day will be held on **Saturday**, **August 10**, **2024**, **at 7:00 a.m.** All male residents will assemble in front of the church at 7:00 a.m. to sign-in.

It is mandated by the Tribal Council that <u>all male community residents between the age of 16</u> and 65 shall participate in all community work: ditch cleaning, Pueblo clean-up, etc. Failure to participate will result in certain privileges that will not be afforded to you. (Hunting, Wood & Dirt Permit).

To be excused from these activities you must have a doctor's verification submitted to the Governor's Office that you are medically unable to participate or disabled.

Rescheduled Community Meeting - Secretarial Election

The Community meeting that was scheduled for this Friday August 2, 2024 will now be rescheduled for Friday August 23, 2024 at 6:00 pm on the gym floor. The rescheduling is due to preparation for our upcoming Feast Day activities.

The purpose of the Community meeting is to provide information regarding a process for any future proposed amendments to our Constitution.

The foundation of our Pueblo's Government is our Constitution which was written and approved back in 1935. Yet, currently the only way to amend the Constitution is through a process known as a "Secretarial Election".

A Secretarial Election is a very involved process that is governed by federal government regulations and overseen by the Department of Interior – Bureau of Indian Affairs.

The Tribal Council has discussed and determined there is a need to implement a process for future amendments to the Constitution, so that is the reason why we must engage in a Secretarial Election.

It is important to understand that if this process is approved by majority Tribal Member vote, by those over the age of 18, there will be safeguards created to ensure that any future proposed amendments reflect the will of the Community.

So, for this reason the Tribal Council has determined a Community meeting be called to provide information and identify the process to be followed for any and all future amendments to the Pueblo's Constitution.

The proposed amendment would only remove the Bureau of Indian Affairs (BIA) from the process to amend our Constitution. It would not affect the BIA's trust responsibilities to the Pueblo nor impact the BIA's inherent federal functions. This would allow the Tribal Council as the Legislative Branch of our Government to consider any future Constitutional amendments which again would need to be approved by a majority vote of Santa Clara Tribal members before being considered as approved.

On this day the flow of traffic will turn into a one-way street on (1) Back Wall Road South to Cloud Road (Orange line on map) (2) Hillside Road Southeast to Back Wall then South on Cloud Road (Orange line on map) (3) Drum Road South onto Cloud Road then South exiting at State Road 30(Orange Line on map).


Wild Rose Road will be closed for the day on August 12th 2024 at the entrance/exit off State Road 30 and at KEE Street, this area will be used for over flow of vendors (Red line on map).

This will take effect at midnight on August 11, 2023, as we get ready for vendors set up at 5am of the 12th.

RE: Reopening of roads on the North and South sides of Main Canyon Area.

This letter is to inform the Community that the roads are reopened on the North and South Side Areas.

To get to the North Side roads SCP Members will have to enter off of Forest road 144/31mile road (Green line on Map), through the Bureau of Land Management (BLM) (Orange line on map), then go through the East gate (Red Line on map) which will be unlocked. See map attached.

South side roads will also be reopened on 601/ Upper Canyon road to the cattle guard before entering the main Canyon by old dump.

Gates were place both on the North and South side areas, where access is prohibited to enter the main stem of the Canyon. The lower canyon road still has wash outs on the road in some areas, and therefore the gate on the lower canyon road will remain locked at the first cattle guard.



In 2024, we started with assisting the Head Start with Heights & Weights in January, February we had a Health presentation/Cooking demonstration for Heart Health and included was the FACE Program from Khapo Community School.

In March we had Health Presentation of "Beyond the Table" in attendance was the FACE Program.

April was "Love your Veggies" with community and FACE Program.

In May we assisted the Department of Youth & Learning with fruits and snacks for the annual Memorial Day Run at Puye Cliffs, and we had a cooking session with Diane Phillips, IHS Nutritionists on May 9, "Low Carb Spaghetti Squash".

For our summer sessions with the Department of Youth & Learning for the Youth of the Community we were scheduled to do health presentations on Tuesdays: July 2-Drinking water is very Important! Every living thing needs water; July 9- "Healthy Eating" Diane Phillips/IHS Nutritionist and fruit popsicles were made, July 16-"Smart snacking tips for Kids" Energy Balls were made, July 23-"Fruit Parfaits were made and the youth were asked about the sessions pictures and comments were collected, July 30-"Sun protection for children/adults and the youth made snack with celery, cream cheese, peanut butter, Nutella, vegetable cream cheese.




Calendar update

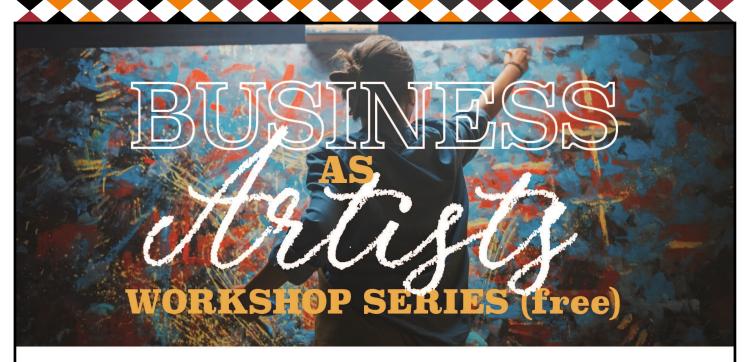



Blue Bus Announces Service Improvements for Bus Routes in Española, Taos, Red River and Chimayó

NCRTD to restore suspended routes and extend service hours in August following new driver hires

Thanks to the hiring of additional drivers, effective Aug. 5, 2024, the North Central Regional Transit District (NCRTD) Blue Bus is pleased to announce a series of bus service improvements across North Central New Mexico.

Blue Bus service for key routes in Taos, Española, Red River and Chimayó will be restored or extended. In addition, beginning on Aug. 3, more bus trips are being added for summer service on the Blue Bus's popular Mountain Trail route serving the Santa Fe National Forest.

The NCRTD was forced to reduce bus service operations on its Española and Taos routes in January of 2024 due to a critical shortage of available drivers. Service to Red River has been suspended since November of 2021 following the pandemic which led to a labor shortage across the Blue Bus service area.

"We are pleased to take these significant steps to restore our free public bus service to communities across North Central New Mexico," said Anthony Mortillaro, NCRTD executive director. "We have made considerable progress over the past six months to recruit, hire and train qualified, and caring professional drivers and we hope to restore or expand service to more communities in the coming months."

The NCRTD is also working with Pueblo tribal communities in Santa Clara, San Ildefonso, and Tesuque to improve bus service routes with a goal to implement significant route improvements in October of 2024.

Upcoming service improvements include:

Española area

- 100 Riverside: Extending service hours to operate from 5:40 a.m. to 6:50 p.m. Monday through Friday. Since January the route has been operating from 8:40 a.m. to 3:16 p.m.
- **110 Westside-Crosstown**: Restoring the route to operate from 7:45 a.m. to 5:15 p.m. M-F. The route was temporarily suspended in January.
- **150 Chimayó**: Restoring service to Las Trampas, operating from 6:00 a.m. to 7:15 p.m. Monday through Friday. Service to stops in Truchas and Las Trampas was suspended in January.

- **310 Red River**: Restoring the route to operate from 5:55 a.m. to 6:40 p.m. Monday through Friday. The route was suspended in November of 2021.
- **340 Chile Line Red**: Extending service hours to operate from 7:00 a.m. to 6:53 p.m. Monday through Friday. Since January the route has been operating from 8:45 a.m. to 2:57 p.m.
