## Santa Clara Canyon Recent Floods and Closures

**Since the most recent devastating Las Conchas wildfire Santa Clara Pueblo Forestry and Office of Emergency Management have completed numerous milestones in restoration and community protection.**

Santa Clara Pueblo Canyon for the past 20 plus years has been closed to the community due to unsafe environmental conditions from the Las Conchas fire and subsequent flooding. Just recently the Canyon was reopened to the community of Santa Clara residence for day use, hunting and wood gathering. Unfortunately, this monsoon seasons the canyon experienced some rain events which produced 4 inches of rain in several hours. This caused some areas to wash out roads and fill the creek bottom with rocks, sediment, and woody debris cutting off access to third and fourth pond.

The Office of Emergency Management has been working tirelessly to get documentation of damages to the Santa Clara Canyon in anticipation of a disaster declaration. This has led the Santa Clara Canyon to close to the public once again. The Office of Emergency Management has been monitoring the weather, and creek along with environmental conditions. Once conditions allow arrangements will be made for continued assessments of those areas which include projects like permanent road,

pond development, restoration, tree planting, Hazardous fuels reduction, prescribed fire, and creek restoration.

## Seed Storage and Greenhouse Facility to include a Community Garden

**Since past events such as wildfires and flooding the Santa Clara Canyon has been closed to residents. As the climate becomes hotter, and drier the outlook for the future remains uncertain.**

As we go into the future of climate change stronger wind events, wildfires, and rainstorms along with prolonged hotter drier days. These changes effect the environment by replacing native tree stands, and native vegetation. The threat of invasive species is a concern with things starting to change and replace those native species which negatively impacts wildlife as well.

## Partnership

The Santa Clara Forestry and Santa Clara Agriculture have partnered to construct two High Tunnel growing facilities. One of the facilities will be for a community garden and the other for propagating native tress like Douglas fir, Engelmann Spruce, Blue Spruce, Ponderosa Pine which are collected by the Forestry department from their Forest Development Program.

The other part to this partnership has developed and constructed a cement pad to hold a walk-in freezer as to store seeds collected over time for the purpose of replanting areas still impacted by the Las Conchas wildfire. That and to safely store agricultural seeds like corn, beans, and Indian Tabacco to name a few. This will help in the preservation of traditional farming practices well into the future.

## The observer

**There has been reports of a parasitic plant identified by the name of Dodder *Cuscuta* found along Santa Clara roadways and in some of the resident's properties. The most common found in north America is the five angle -dodder (*cuscta pentagonia*).**



The dodder produces two types of specialized stems called haustoria that will penetrate the host's own stem. One form of haustorium will tap into the host's water conducting xylem, while the other type will surround the food-carrying phloem. Dodders may parasitize a single species or several different types of hosts. Several species are considered agricultural pests, especially those that specialize on tomatoes, alfalfa, and pumpkins. In addition to sapping their victims of their own food and water, dodders can also transmit destructive plant viruses. The Santa Clara Forestry department does have an invasive species plan reservation wide to address such problems although this is the first documented plant parasite we have experienced along Santa Clara roadways.



This plant was spotted by tribal member Mathew Tafoya who pointed out its location along Canyon Road at the entrance of Roller property. We are actively pursuing funding to clean up areas where it has spread to along the roadways. Our crew along with some youths have cut some of the infected plants at the base and bagged up the remains to burn and dispose of at a later date. There are more increasing sightings of the parasite occurring along roadways. Although the plant is a parasite it does not have any documented toxic effects to humans. It has been used in Chinese medicine and has some medicinal qualities.

We have let the Bureau of Indian Affairs along with NRCS know of the plant. It has been found in Rio Arriba County and apparently here for a while. If you go on-line, you can find more information on the parasitic plant by going to Department of Agriculture website to find out more information on this plant. ## Prescribed Fire (Rx)

The Santa Clara Forestry Department has scheduled a prescribed burn this fall / winter of 2024. This area which has been treated previously with Mistletoe sanitation, logging, and hazardous fuels treatments. The Plaza Largo drainage and turkey flats have seen prescribed fire before. Plans include to engage a broadcast burn on 1,250 acres along the northside Forest Service and BLM boundary fence. The Forestry Department has been coordinating with various agencies over the past several years to conduct a series of final treatments that are geared towards Forest Health. The final pieces of the puzzle are the burn plan, and Clearances to conduct the burn. Once the plan and clearances have been approved the burn will be then proceed with a final notice to the community as to the dates of the burn, If you have any questions regarding the plans please don't hesitate to contact Santa Clara Pueblo Forestry Department at 505-692-6274.

### **SANTA CLARA PUEBLO SOCIAL SERVICES PROGRAM**

The Santa Clara Pueblo Social Services objective is to improve the quality of life for tribal community members of Santa Clara Pueblo and to protect the children, the elderly, and disabled from abuse and neglect. The Program also supports at-risk families to allow children to remain with their families.

Our Program consists of Welfare Assistance which includes Burial and General Assistance and Foster Care. The Program also implements the Indian Child Welfare Act (ICWA). The purpose of the Indian Child Welfare Act is “to protect the best interest of Indian children and to promote the stability and security of Indian tribes and families for the removal of Indian children and placement of such children in homes which will reflect the unique values of Indian culture”. ICWA is a Federal Law which was enacted after the Federal Government recognized that American Indian children were being removed from their homes and communities at a much higher rate than non-Native children.

Our Staff consists of our Director, Terrie Chavarría who has been with the Program for 15 years, as an ICWA Worker, a Tribal Social Caseworker and most recently as our Director. We also have Ann F. Gutierrez, Administrative Assistant, who has worked for the Program for 11 years; and Jacqueline Wright, our Tribal Social Caseworker who has been with us for 3 years and has extensive experience in child welfare.

Social Services also participates in Community Outreach; Prevention and Awareness activities; and collaborative efforts with other Tribal departments which may benefit the children and families of our Pueblo. Our Program encourages tribal foster home recruitment and retention to become licensed within the exterior boundaries of Santa Clara Pueblo. This includes Foster Parent trainings, and we provide referrals for Parenting Classes.

## Fentanyl

### WHAT IS FENTANYL?

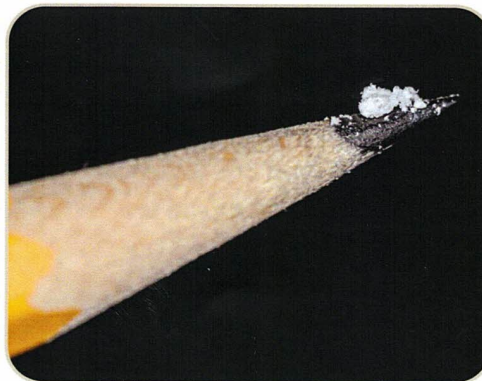
Fentanyl is a potent synthetic opioid drug approved by the Food and Drug Administration for use as an analgesic (pain relief) and anesthetic. It is approximately 100 times more potent than morphine and 50 times more potent than heroin as an analgesic.

### WHAT IS ITS ORIGIN?

Fentanyl was first developed in 1959 and introduced in the 1960s as an intravenous anesthetic. It is legally manufactured and distributed in the United States. Licit fentanyl pharmaceutical products are diverted via theft, fraudulent prescriptions, and illicit distribution by patients, physicians, nurses, physician assistants, nurse practitioners, and pharmacists.

From 2011 through 2021, both fatal overdoses associated with misuse of clandestinely produced fentanyl and fentanyl analogs, and law enforcement encounters increased markedly.

According to the Centers for Disease Control and Prevention (CDC), overdose deaths involving synthetic opioids, excluding methadone were involved in roughly 2,600 drug overdose deaths each year in 2011 and 2012, but from 2013 through 2021, the number of drug overdose deaths involving synthetic opioids, excluding methadone increased dramatically each year, to more than 68,000 in 2021. The total number of overdose deaths for this category was greater than 258,000 for 2013 through 2021. These overdose deaths involving synthetic opioids is primarily driven by illicitly manufactured fentanyl, including fentanyl analogs. Consistent with overdose death data, the trafficking, distribution, and misuse of illicitly produced fentanyl and fentanyl analogs positively correlates with the associated dramatic increase in overdose fatalities.

### What are common street names?

Common street names include:

- Apache, China Girl, China Town, Dance Fever, Friend, Goodfellas, Great Bear, He-Man, Jackpot, King Ivory, Murder 8, and Tango & Cash.

### What does it look like?

Clandestinely produced fentanyl is encountered either as a powder or in fake tablets and is sold alone or in combination with other drugs such as heroin or cocaine.

Fentanyl pharmaceutical products are currently available in the following dosage forms: oral transmucosal lozenges commonly referred to as fentanyl “lollipops” (Actiq®), effervescent buccal tablets (Fentora®), sublingual tablets (Abstral®), sublingual sprays (Subsys®), nasal sprays (Lazanda®), transdermal patches (Duragesic®), and injectable formulations.

### How is it used?

Fentanyl can be injected, snorted/sniffed, smoked, taken orally by pill or tablet, and spiked onto blotter paper. Illicitly produced fentanyl is sold alone or in combination with heroin and other substances

and has been identified in fake pills, mimicking pharmaceutical drugs such as oxycodone. Fentanyl patches are misused by removing its gel contents and then injecting or ingesting these contents. Patches have also been frozen, cut into pieces, and placed under the tongue or in the cheek cavity. According to the National Forensic Laboratory Information System - National Estimates Based on All Reports estimates, reports on fentanyl (both pharmaceutical and clandestinely produced) increased from 4,697 in 2014 to over 117,045 in 2020, as reported by federal, state, and local forensic laboratories in the United States.

### **What is the effect on the body?**

Fentanyl, similar to other commonly used opioid analgesics (e.g., morphine), produces effects such as relaxation, euphoria, pain relief, sedation, confusion, drowsiness, dizziness, nausea, vomiting, urinary retention, pupillary constriction, and respiratory depression.

### **What are the overdose effects?**

Overdose may result in stupor, changes in pupillary size, cold and clammy skin, cyanosis, coma, and respiratory failure leading to death. The presence of a triad of symptoms such as coma, pinpoint pupils, and respiratory depression are strongly suggestive of opioid poisoning.

### **Which drugs cause similar effects?**

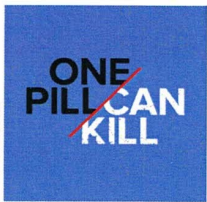
Drugs that cause similar effects include other opioids such as morphine, hydrocodone, oxycodone, hydromorphone, methadone, and heroin.

### **What is the legal status in the Federal Control Substances Act?**

Fentanyl is a Schedule II narcotic under the United States Controlled Substances Act of 1970.

The tests will detect current COVID variants and can be used through the end of the year, according to the Department of Health and Human Services. Tests will start shipping the week of Sept. 30, per the site.

### **COVID tests expiration dates**

For some previously distributed tests, expiration dates were extended to account for data that revealed a longer than expected shelf-life.

A full list of approved tests and their revised expiration dates is posted on the FDA website.
