

JURY TRIALS ARE COMING TO SANTA CLARA

The Santa Clara Pueblo Tribal Code provides individuals charged with crimes that carry the possibility of imprisonment with the right to a trial by jury. The first jury trial in the history of Santa Clara is scheduled for the end of February.

The Tribal Code provides that the Court may summon up to 20 prospective jurors for each jury trial. Juries in criminal cases will consist of six people seated by the Chief Judge.

Jurors are selected at random from enrolled adult members of the Pueblo. Jurors will receive a payment of \$15 per hour for each hour of service, plus mileage to the Courthouse.

A summons for jury duty will be mailed to potential jurors from the Tribal Court. Please reach out to Court Administrator Gail Yepa if you have any questions at (505) 753-0411.



FREE PREPARATION IF REQUIREMENTS ARE MET:

Family's Annual Income is \$57,000 or less or if you are age 65 or older.

REQUIRED DOCUMENTS!

- Identification:
 - Must have photo ID (Driver License, State Issued ID, Passport, Military ID, Tribal ID)
 - Social Security Number
 - Or Individual Tax Identification number (ITIN) for yourself, your spouse, your dependents, or anyone else on your return
- Income Forms: All W-2 forms, 1099 forms (Miscellaneous income, Interest, Dividends, etc.)
- Proof of Healthcare: Form 1095-A or exception number from the healthcare marketplace
- Expense forms:
 - All 1098 Forms (Mortgage and Tuition statements)
 - Child or dependent care expenses
 - Property Tax payments
- Prior year tax returns (if you have it)
- Bank Routing and account number (if you qualify for a refund and want a direct deposit)


